Payment Policy & Working Agreement Starting 3/1/2023

Scheduling Policy/Booking Appointments:

Upon making an appointment for a Reiki treatment, payment for treatment will reserve the appointment time for the Healee. An invoice will be emailed that will be paid online.

One Reiki treatment is 60 minutes for \$65.

With Intuitive Guidance, an additional 45 minutes is allotted to account for discussions before and after the 60-minute Reiki treatment for a total of \$85.

A Package of 3 Treatments for Reiki + Intuitive Guidance is \$230

A Package of 5 Treatments for Reiki + Intuitive Guidance is \$365

If, additional time is needed for any treatments that are part of a package and the appointment exceeds the 105 minutes allowed for treatment and processing, the client will be charged for the extra time needed for treatment.
